<u>Introduction</u>

April marked the seventh month of our third year of operations with \$494 in net profit for donations received exceeding expenses paid. To date, the Jason Fritz Memorial Endowment has a \$1,000 spendable balance and a \$12,461.48 permanently restricted balance whose investment earnings will be used to support future scholarships.

No new scholarships were awarded during April, though two previously awarded payments were cashed during the month. To date, we have received sixteen scholarship applications this fiscal year and have awarded two scholarships. The Jason Fritz Memorial Scholarship is live for applications and has received two applications!

Outreach efforts over the past two months have been successful in bringing in scholarship applicants. The scholarship fund has a link hosted on the DCI website and our organization has attended both the Michigan Color Guard Circuit and Michigan Alliance for Performing Arts championship events. That said, these efforts have also shown a need to prioritize fundraising to meet the scholarship fund's goals and to support Michigan students.

Financial Narrative

Cash for the month is \$494.00 higher than March for donations received minus our monthly Digital Ocean expense. \$205 of the total cash on hand is restricted to maintain minimum reserve requirements and \$49 is restricted for the Jason Fritz Memorial Endowment for donations to be transferred to BCCF.

Program related expenses had no activity during April. Administrative expenses are up \$6.00 for the monthly Digital Ocean invoice.

One contribution for \$500.00 was received during April. Restricted funds for the Jason Fritz Memorial Endowment are broken down as follows: \$12,461.48 is permanently restricted as the corpus of the endowment and \$1,000 is invested as an opening spendable balance. Endowment earnings will be separately classified as investment performance reports are received and become available for use solely for the purpose of the Jason Fritz Memorial Scholarship, subject to availability of funds and applicant interest. To date, no investment activity reports have been received from the Battle Creek Community Foundation so no revenue or expenses have been recorded. Unused funds will be reinvested in the corpus of the endowment. All funds are managed in accordance with Generally Accepted Accounting Principles in the United States.
